Construction of the first 1.1 miles of the Squannacook River Rail Trail was completed in 2021. The rail trail has already become very popular. A user count was held on Oct. 24, 2021, and over 100 people used the trail that day. Phase 2 of the rail trail, a 0.71 mile section from Old Meetinghouse Road to Harbor Church in Townsend, MA, was begun in Dec. 2021.

Squannacook Greenways is pursuing the construction of a pedestrian bridge over the Squannacook River on Old Meetinghouse Road in Townsend. In 2021 our contractor has been working hard on permitting issues.
