Squannacook Greenways passed a major milestone in 2019, because construction has finally begun! In order to do this, we had to finish permitting in the town of Townsend, which was done in July 2019. We also won a MassTrails grant in June 2019 for \$27,780. In October and November of 2019 he held two volunteer days with over 80 volunteers showing up to install 1.5 miles of wattles required by permitting to protect the wetlands. In December 2019, tree clearing began along the entire rail trail, and was almost complete at year's end. The rail trail is now completely free of trees, and we are preparing to pull up the rails and ties and install stone dust along 1/3 of the rail trail during the next build season allowed by permitting - November to March.
